As you see above, branded fares are not applicable for the whole TK network. Only for flights, from/to Turkiye, branded fares will be applicable. For beyond journeys (i.e. PAR X/IST BAH), branded fares will not be found.

2. AJET BRANDED FARES

2.1 BRAND CONTENT

In this section, brand names and contents those will be valid for AJET flights will be mentioned. As you know, business cabin is not applicable for AJET flights.

2.2 BRANDED FARES O&D SCOPE

Branded Fares will be applicable for all AJET network as follows:



Table 6: AJET Branded Fares O&Ds

AnadoluJet brands are applicable for all journeys including beyond and for the whole network. As an exception, TLV and IRAN tickets (when TLV and IRAN is origin point) will be refundable and changeable for each brand.

3. BRAND RESTRICTIONS

For TK Network, in case of reissue, from brand to brand following rules will be applied:

- CL Brand → Changes not permitted.
- LG Brand → Changes permitted with penalty to LG, BF, BL, JS(AJET).
- FL Brand → Changes permitted with penalty to FL, BF, BL, JF(AJET).
- BF Brand → Changes permitted with penalty to BF.
- BL Brand → Changes permitted without penalty to BL.

For AJET network,

- JR Brand → Changes not permitted.
- JS Brand → Changes permitted with penalty to JS, LG, BF, BL.
- JF Brand → Changes permitted with penalty to JF, FL, BF, BL.

TLV and IRAN are exceptional routings for both TK and AJET, as we mentioned above. So in case of reissue for those tickets,

- CL Brand → Changes permitted to CL or JR.

For other brands, same rules above will be applied.

4. APPLICATIONS in TROYA

In this section, applications and entries in TROYA, those are changed together with YDUS, will be mentioned.

4.1. ABOUT FARE BASIS

Below you will find two fare basis examples, including brand codes and some kind of information about fare types or levels.




Table 7: TK Fare Basis with Brand Code




Table 8: AJET Fare Basis with Brand Code

Fare quotation entry, FQ-*PTC must be used especially for VFR, LBR, GIT and ITX. Because, fares for these passengers are not a kind of discount, they are special fares.

4.4. FARE QUOTATION ENTRIES

FQBB: Fare Quote Best Buy with EcoFly.

FQ: Fare Quote with EcoFly, booking class already defined.

FQBBCP:** Fare Quote Best Buy in business cabin with BusinessFly.

FQBBBF@FL: Fare Quote Best Buy with PrimeFly.

FQBB: Fare Quote Best Buy

BF: Branded Fares

@: Symbol (mandatory)

FL: Brand code

FQBF@LG: Fare Quote with ExtraFly, booking class already defined.

FQBF@JF: Fare Quote with ComfortJet, booking class already defined..

FQBBBF1@FL.2@LG: Fare Quote Best Buy, segment 1 with PrimeFly, segment 2 with ExtraFly.

FQBF1@CL.2@LG: Fare Quote, booking class already defined, segment 1 with EcoFly, segment 2 with ExtraFly.

FQBBBF@FL/P1*ADT.2*CNN: Fare Quote Best Buy with PrimeFly, first passenger is an adult, second passenger is a child.

FQBF@FL//ACCOUNTCODE: Fare Quote using Account Code, with PrimeFly.

Since award tickets are not within scope, there will be no change about their fare quotation entries.

FQ-*GIT*USD*/10: Branded Fares will not be applicable for group tickets, so the fare quotation entry is the same.

When the fare quotation entry with Branded Fares indicator is used for a passenger type code where brands are not applicable, system will return an error message.

Entry: FQBF@LG/P1*ZEA

Response: NOT SUPPORTED FARE QUOTE FORMAT FOR THIS TICKET TYPE

FQBBBF@FL/P1*ADT.2*CNN.R: Automatic Reissue Fare Quote Best Buy with PrimeFly, 1st passenger is an adult, 2nd passenger is a child.

FQBF@FL/P1*ADT.2*CNN.R: Automatic reissue fare quote, booking class already defined, with PrimeFly 1st passenger is an adult, 2nd passenger is a child.

Automatic refund entry, **FQREF** is still valid for use.

4.4.1 FARE QUOTATION for EXST and CBBG

As you know from the last announcements (12 January 2021), fare quotation for EXST can be done automatically, for both international and domestic flights.

Now, let us mention the entries with Branded Fares indicator:

FQBF@FL/P1*ADT*/EXST01: 1st is an adult, 1 EXST is requested, with PrimeFly

FQBF@FL/P1*ADT*/EXST01.P2*CNN08: 1st is an adult, 1 EXST is requested, 2nd passenger is a child with no EXST request, PrimeFly

FQBF@FL/P1*ADT*/EXST01//CAR: Fare Quote with Account code

Fare Quotation for CBBG can be still done manually.

4.5. FARE TARIFF ENTRIES

FXISTAMS01SEP@-BFFL: Fare Tariff for Istanbul-Amsterdam on 01 September, with PrimeFly

FXISTAMS01SEP*CNN@-BFFL: Fare Tariff for child.

For a destination which is out of scope, if you use fare tariff entry with branded fares indicator, error message will be received.

Entry: FXISTNYC01SEP@-BFFL

Response: BRANDED FARE NOT FOUND

FXISTAMS01SEP@-BFFL-OW: Only oneway fares.

FXISTAMS01SEP@-BFFL-RT: Only return fares.

FXISTAMS01SEP22-RT.T31DEC21: With Ticketing Date, 31DEC21.

4.6. APPLICATIONS

EXAMPLE 1:

Passenger would like to travel from Istanbul to Paris on 10 March in economy cabin and also requests best buy fare with EcoFly. Here is the itinerary,

As you see above, fare quotation is completed automatically under guarantee, booking class is T with EcoFly. After confirmation, let us complete all mandatory fields of PNR and then save.

You can check the brand information on Apfax field line number 2. If passenger would like to choose another brand, you can delete the fare via **CX** and then **FQBBBF@LG** for ExtraFly or **FQBBBF@FL** for PrimeFly.

As you see in fare notes, changes penalty is 70 USD and new local fare must be equal or higher than the old local fare. Taking into account the brand restrictions (See, Chapter 3), you can complete the transactions automatically.

Since Tunisia is not within Branded Fares O&D scope, there is a default fare basis on ticket.

Also CAI is the destination where branded fares are applicable. So passenger must select one of the brands in economy cabin. But do not forget about the rule, "New Fare may be equal or higher"

After creating the new itinerary, put MEV and here is the automatic reissue entry:

5. APPLICATIONS ABOUT SEAT SELECTION and CHECK IN PROCESS

- Between the last 24-6 hrs, standard seats can be selected with no additional collection according to the brand information on the ticket, for the passengers who do not want to buy any seat, random seat will be assigned via checkin services.
- If passenger would like to buy another seat instead of his standard seat selection or automatically assigned seat, between 24-6 hrs, payment can be completed.
- When there is less than 6hrs, since seats are closed for sale, passenger can select one of the standard seats according to brand information on ticket. If passenger has no right for seat selection, check in must be completed with randomly assigned seat.
- Once EMD is issued for seat selection together with the ticket, between 24-6hrs, seat change is not possible. If less than 6hrs, passenger has only one chance to select one of the standard seats instead of his/her paid seat. EMD amount will not be refunded.
- During checkin process, Business Class passengers can select one of the standard seats, without any collection.
- For the tickets issued before YDUS, seat selection is not applicable.
- Elite and Elite Plus card holders have the right for seat selection, even they have the ticket with EcoFly. For AJET flights, there is no privilege for M&S passengers.

APPENDIX 5: FREQUENTLY ASKED QUESTIONS

- 1) For which type of journeys, TK branded fares are applicable?
 - From/To Turkey, oneway, return and openjaw journeys where public fares are applicable. Only for beyond journeys, branded fares will not be applicable.
For example, for the itinerary PAR X/IST DXB, there will be no brand.
- 2) Is the all network for TK eligible for brands?
 - No, for TK; Europe, Middle East and North Africa (for some selected points) are eligible.
- 3) For which type of journeys, AJET branded fares are applicable?
 - Branded fares for AJET are applicable for all type of journeys, including beyond.
- 4) Is the all network for AJET eligible for brands?
 - Yes, for AJET, all network is eligible for brands.
- 5) Is it possible to combine different brands for a return journey?
 - Yes, for example, outbound fare component with EcoFly, inbound fare component with ExtraFly.
- 6) If yes for Question 5, which rule will be applied in case of reissue?
 - If passenger would like to change outbound only, outbound fare component's rule will be applied. If passenger would like to change inbound only, inbound fare component's rule will be applied. If passenger would like to change the whole ticket, most restricted rule will be applied.
- 7) In case of reissue, is it possible to change the brands?
 - Within the same cabin, no. Only from economy cabin to business cabin, it is possible. For example, ticket with ExtraFly can not be changed to PrimeFly, but can be changed to BusinessFly or Business Prime; of course charges and penalties will be applied.
- 8) What is the rule for an unused ticket's refund, if it is issued for a return journey with different brands?
 - Most restricted rule will be applied, as usual.

9) For the tickets issued before YDUS, what must be done in case of reissue after YDUS?

➤ Fare rules will be applied as usual and one of the brands will be offered. After YDUS, within the O&D scope, all tickets must have a brand.

10) In case of reissue, can transactions be done automatically or manually?

➤ From no brand to branded fare, this transaction will be completed automatically. From branded fare to no brand, this transaction must be completed manually.

11) Are branded fares applicable for award tickets?

➤ No, award tickets are out of scope.

12) Are branded fares applicable for pass tickets?

➤ No, pass tickets are out of scope.

13) Imagine a passenger holding ticket with ExtraFly and also XBAG EMD. In case of reissue, is the existing XBAG EMD still valid?

➤ Yes, passenger can either use XBAG EMD on new flight or request refund.

14) Is it possible on Troya system, to apply different brands for different passengers on same PNR?

➤ No.

15) Is it possible on GDSs, to apply different brands for different passengers on same PNR?

➤ Yes.

16) If there is the right for seat selection within the brand, are exit/legroom seats for free?

➤ No, Exit/legroom seats are still paid. Seat selection is valid for standard seats.

17) If passenger holding a ticket with EcoFly/EcoJet, is it possible to issue XBAG EMD at the airport?

➤ Yes, if passenger has baggage, XBAG EMD must be issued.

18) Is there any difference about excess baggage calculations?

➤ No, it is same as usual.

19) What is the relation between reservation classes and brands?

- All reservation classes (except G, X, I, R, N) are included in each brand. For example, L class with EcoFly has no baggage allowance and reissue is not permitted. But L class with ExtraFly has baggage allowance and reissue is permitted.

20) What will be the situation for the destinations which are out of scope?

- Default fare systems-fare basis and rules are still valid.

21) Are branded fares applicable for every passenger type? How about fare quotation for different passenger types?

- No, please check Chapter 4.3
Fare Quotation must be done via FQ*-PTC entry especially for GIT, ITX, VFR and LBR.

22) How about corporate fares? Are they out of scope?

- Yes, branded fares are not applicable with corporate fares.

23) What will be the service for combined flights, TK+AJET?

- For combined flights, passenger will be informed about the service during flight. But in case of fare calculation, there will be no difference.

24) Is it possible to check the details for each brand on the system?

- Yes, both for Troya and GDSs fare rules will be visible.

25) What will be the procedure if passenger would like to change any TK ticket to AJET ticket?

- Automatic reissue will be done. Please check Chapter 3.

26) What is the difference between these two applications in PrimeFly and BusinessPrime?
“Same day changes” and “reissue allowed”?

- “Same day changes” will be applied with no charge. Reissue allowed means there is no penalty, but if there is fare difference it must be collected. “Same day changes” can be done at sales office, call center and airport.

27) If a reservation class is closed for one of the brands, then how about others?

- If V class is closed for EcoFly, then it is closed for ExtraFly and PrimeFly too.

28) What is the procedure for Random Seating?

- Between the last 24-6 hrs, standard seats can be selected with no additional collection according to the brand information on the ticket, for the passengers who do not want to buy any seat, random seat will be assigned via checkin services.

When there is less than 6hrs, since seats are closed for sale, passenger can select one of the standard seats according to brand information on ticket. If passenger has no right for seat selection, check in must be completed with randomly assigned seat.

29) Do Elite & ElitePlus passengers have the right for free seat selection?

- On TK flights, for each brand they are allowed to select standard seats. For AJET, there is no other privilege, brand contents will be applied.
