To the attention of all stations, where iPort DCS is used for Weight and Balance!

To avoid misunderstandings with the flight crew and to prevent flight delays, the Notification to Captain (NOTOC) for SKYUP MT flights shall be issued ONLY for the Special Load commodities listed below:

DOC	Day old chick
EAT	Foodstuffs for human consumption other than meat, fish and seafood
ELI	Lithium ion batteries excepted as per Section II of PI 966 and 967 or sodium ion batteries excepted as per Section II of PI 977 and PI 978 (ref. IATA DGR, current edition)
ELM	Lithium metal batteries excepted as per Section II of PI 969 and 970 (ref. IATA DGR, current edition)
FIL	Undeveloped/unexposed films

PEF	Flowers

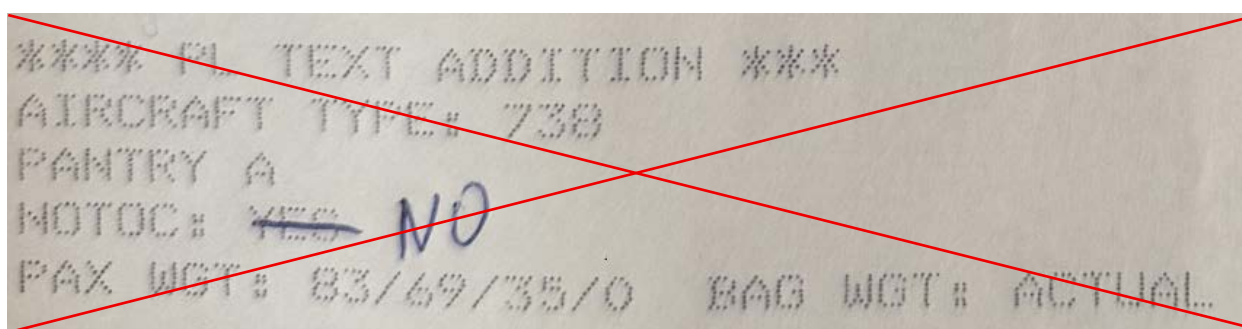

**Note 1:** Any time when the padlock is unlocked or blocked, or if the flight status is changed, the “**NOTOC needed**” field will automatically revert to “**Yes**”. Therefore, we recommend performing this adjustment only once the Loadsheet has been finalized to avoid the risk of overlooking this remark.

**Note 2:** If the “**Yes**” option has not been changed to “**No**” as described above and Loadsheet has been issued, manual corrections are not allowed and new Loadsheet shall be produced with “**NOTOC needed**” option corrected.
