

Immigration Bulletin – 09/2025

The purpose of this immigration bulletin is to provide a monthly snapshot of significant regulatory updates with respect to entry requirements and common errors recorded while performing document verification during our operations. It aims at promoting awareness, minimizing the risk of future operational issues at airports, and reducing fines and costs associated to possible mistakes. DESTINATION THAILAND

Starting from **1st May 2025**, all **non-Thai nationals** entering Thailand (including foreign residents with long-term visas or work permits) must complete the **Thailand Digital Arrival Card (TDAC)** registration, before their arrival in the country or before reaching the immigration checkpoints.

TDAC is an *online* entry form, designed to replace the traditional paper-based arrival card by digitally collecting passport information, travel and accommodation details, to **pre-screen** arriving foreign travelers of any nationals and make immigration faster, easier and more secure.

Pre-registration is permitted up to three (3) days prior to arrival by registering at <http://tdac.immigration.go.th>.

At the end of the registration process, travelers will receive a confirmation e-mail, along with a personal QR code for any further updates:

Kindly ensure that the information provided is accurate and aligns with your travel documents to avoid any issues upon your arrival in Thailand. You may update your information within three (3) days (including the day of arrival) before entering Thailand.

 The following data, once submitted, cannot be changed: *given name, family name, passport number, nationality, and date of birth.*

In the event of any errors in these fields, a **new registration** must be carried out.

In case of a change of flight number, passengers can directly amend the existing TDAC.

ATTENTION:

Passengers who have not completed TDAC before departure **shall not be denied boarding** but **must be informed** that they will have to register upon arrival using kiosks available at the airport before proceeding to immigration.
