## Ancillary Baggage Products

### 1. Baggage Product Overview

ITA Airways offers a variety of ancillary baggage products, giving passengers the possibility to transport luggage that exceeds the regulations of the free baggage allowance in size, weight and/or number of items. Additionally, the chargeable transport of animals either in the cabin or in the aircraft's hold (AVIH & PETC) is also part of this product category.

#### SPECIFIC REGULATIONS:

##### United States of America

For dogs transported to the United States, starting from August 1st, 2024 new procedures must be followed to allow the animal's entry into the U.S., as required by U.S. authorities to prevent the risk of spreading canine rabies. These procedures vary according to whether the countries visited by the dog in the previous 6 months are considered low- or high-risk.

##### United Kingdom

In the United Kingdom, the transport of animals is not permitted, with the exception of assistance dogs. Local Authorities should be contacted if necessary.

##### Israel

The transport of dogs and cats to Israel is regulated by specific legislation.

<sup>1</sup> The new provisions take effect on December 1. All reservations made by November 30 will be honored, and passengers will still be allowed to travel with pets other than dogs and cats until all existing bookings have been fulfilled.

### Brazil

The transport of animals is subject to the International Zoosanitary Certificate (CZI).

### United Arab Emirates:

For flights from IT to DXB, all types of animals must be transported exclusively via cargo

### Transport of brachycephalic pets in the hold

Starting October 26th, 2025, ITA Airways will suspend the AVIH service for all brachycephalic dog and cat breeds due to their increased health risks during hold transport. Bookings confirmed by October 25th, 2025 will still be honored, but no new reservations or changes will be allowed after that date. Transport in the hold will remain available only for non-brachycephalic breeds, and cabin transport will continue according to the established weight and size limits.

## 1.4 Hand Baggage

Hand baggage must weigh no more than 8 kg and measure no more than 118 cm (55 x 40 x 23).

In Economy and Premium Economy, only one piece of hand luggage is allowed. Business Class passengers could also bring the **secondhand bag** in the cabin (in addition to personal item). In case of upgrade, the application of the original ticket will be applied in economy or premium. Because of different local regulations for flights from USA and from INDIA will be excluded from these new guidelines and will maintain the policy of one piece of hand luggage also in Business Class (INDIA max 115cm).

### 1.5 Checked Baggage

Each baggage can have a maximum size of **158 cm** (the sum of height + width + depth) and a maximum **weight of 23 or 32 kg**, depending on the travel class and destination as detailed in the following table.

## 2. Pricing Concept

The pricing logic for Ancillary Baggage products at LHG is designed to reflect the passenger's journey. Depending on the Ancillary Baggage product, the pricing logic follows different rules. ### 2.1 Zone Concept & Price Group Overview

- **Six different price groups** starting with domestic travel and ending at long intercontinental journeys.

## Ancillary Baggage Products

- **All countries worldwide** are covered by this concept.
- **IATA rules** regarding the Most Significant Carrier and **other legal regulations** (e.g., US-DoT regulations) must be applied.
- The **furthest checkpoint** of a journey defines which price group needs to be applied.
- Prices are valid for journeys **starting in Price Group 1 – 3** and **ending in Price Group 1 – 6**.
- All prices apply for half of the return ticket and sectors travelled without stopovers.
- Journeys starting in price group 4 – 6 and ending in price group 4 – 6 **are always charged according to price group 6**

## 3. Availability/Conditions

### 3.1 Availability

All ancillary baggage products are available to all customers travelling on AZ tickets. Depending on the journey, some special restrictions and/or exceptions may apply. All ancillary baggage products are subject to the current IATA or country specific regulations.

### 3.2 Conditions

As for baggage, the issued EMD is non-refundable but can be reused within one year from the date of issuance.

**Reuse** is allowed in the following cases:

- **Date/Flight Change (Re-Booking):** The EMD can be used to change the original date or flight
- **Itinerary Change (Re-Routing):** The EMD can be used for a new itinerary.

When an EMD is associated with a new ticket, its validity does not automatically follow that of the new ticket; the expiration date of the EMD will remain the same as when it was issued, that is, one year from the date of issuance. Additionally, it can be exchanged for a new service: The interchangeability allows the original EMD to be used to obtain the desired new service, provided that both services fall within the same EMD category (e.g., baggage EMD for all services under baggage charge: extra weight, oversize, 2nd extra piece, etc.)

However, the reuse should not result in a financial loss. If otherwise, the payment of the supplement/difference is required.

**Refunds** may be authorized in the following scenarios:

- Reprotection on a flight not operated by ITA Airways.
- Cancellation of the original flight with rejection of the new flight proposed by ITA Airways.
- Lost luggage was not found within 45 days.
- Death, Illness

**EMD for PETC/AVIH Service:**

- The EMD for pet transportation service can be refunded in case of illness or death of the pet. A veterinary medical certificate is required to confirm the animal's inability to travel due to illness.

## Death/Illness

### **Illness (Before Departure):**

If a passenger cannot begin a journey due to illness, they must cancel the reservation by contacting the Call Center before departure and submit medical documentation issued by a public or S.S.N.-affiliated facility within 7 days of the cancellation request.

Trip Rescheduling:

The passenger can reschedule the journey while maintaining the original itinerary, paying any fare adjustments. The trip must be completed within 3 months from the prognosis end date indicated on the medical certificate. For Covid-19, the trip must be completed within 1 month from the date of the positive test result.

Ancillary Services:

Any ancillary services will follow the ticket rescheduling.

Travel Companions:

They may reschedule the journey if included in the same reservation. If booked under a different PNR, they must provide proof of relationship (State of Family).

Refund:

If not interested in rescheduling, a refund can be requested according to fare rules.

## Illness

### **Illness (Before Departure):**

If a passenger cannot begin a journey due to illness, must cancel the reservation by contacting the Call Center before departure and submit medical documentation issued by a public or S.S.N.-affiliated facility within 7 days of the cancellation request.

The passenger can reschedule the journey while maintaining the original itinerary, paying for any fare adjustments. The trip must be completed within 3 months from the prognosis end date indicated on the medical certificate.

- Ancillary Services: Any ancillary services will follow the ticket rescheduling.
- Travel Companions: They may reschedule the journey if included in the same reservation. If booked under a different PNR, they must provide proof of relationship (State of Family).
- If not interested in rescheduling, a refund can be requested according to fare rules.

## Ancillary Baggage Products

### **Illness (After the Start of the Journey)**

If a passenger cannot complete a journey due to illness, must cancel the reservation by contacting the Call Center before departure and provide medical documentation within 7 days of the cancellation request.

- The journey can be rescheduled while maintaining the original itinerary and paying any fare adjustments within 3 months from the prognosis end date.
- Ancillary Services: Any ancillary services will follow the ticket rescheduling.
- Travel Companions: They may reschedule the journey if included in the same reservation or, if booked under a different PNR, by providing proof of relationship (State of Family).
- Refund: A refund for the unused portion of the ticket can be requested according to fare rules.

## Death

### **Death before the Journey:**

- In case of the passenger's death, a refund of the ticket is possible upon submission of documentation.
- Travel companions may reschedule the journey within 45 days from the date of death, paying any fare adjustments. If booked under a different PNR, they must provide proof of relationship (State of Family).

### **Death during the Journey:**

- In case of the passenger's death, a refund for the unused segment will be issued. Travel companions may reschedule the journey within 45 days, maintaining the original itinerary and paying any fare adjustments.

### **Death of Close Relatives:**

- If the death of a close relative occurs within 10 days before departure or during the journey, the passenger and accompanying close relatives may reschedule the journey within 45 days, upon submission of the death certificate and proof of relationship (State of Family).

Ancillary Services: They will always follow the rescheduling of the main ticket.

## 6.3 Baggage Transport for PWD/PRM

### Free transport in cabin or hold:

- Guide or assistance dogs (SVAN).
- Two mobility aids, such as crutches or a walker.
- Manual, foldable wheelchairs can also be transported in the cabin, but only on Airbus A330 and A350 aircraft.
- Medical devices to be used on board (e.g., POC) with dimensions equivalent to standard cabin baggage.
- Medications, dressings, syringes, or auto-injectors necessary for administration.

**Transport in the hold:**

- One piece of baggage up to 23 kg for medical materials, for example:
  - Incontinence hygiene devices.
  - Drainage devices, such as catheters.

**Additional notes:**

- Special medical equipment provided by the airline, such as stretchers or oxygen therapy devices, is **not included in free transport**, and associated costs are the passenger's responsibility.
- Dimensions and weight of cabin baggage/aids may be specified depending on the type of passenger-owned wheelchair or scooter.
