NOTICE - Whenever the destination is in Italy, the return of weapons and ammunition will be made by the Police Authorities upon delivery of this form.

If during the journey one of the following connections takes place:

- from an international to a domestic flight, or
- from a domestic to an international flight, or
- from an international to an international flight

Passengers are advised to contact ground staff at connecting airports, to get proper information about customs and/or police regulations on export, import or transit of weapons. In this regard it is pointed out that in many Countries, Italy included:

- customs clearance of weapons and ammunition takes place upon arrival at the first incoming airport, even if passengers' bag has been tagged till another destination within the same country.
- export formalities must be carried out at the last domestic station, even though the passenger boarded at a different airport and weapons and ammunition were tagged to a destination outside that country.

The undersigned, declare to have knowledge of the rules and regulations, with regard to licensing, carriage and customs clearance of weapons and ammunition, enforced by the departure, transit and destination countries and to hold the necessary permits thereof.
