



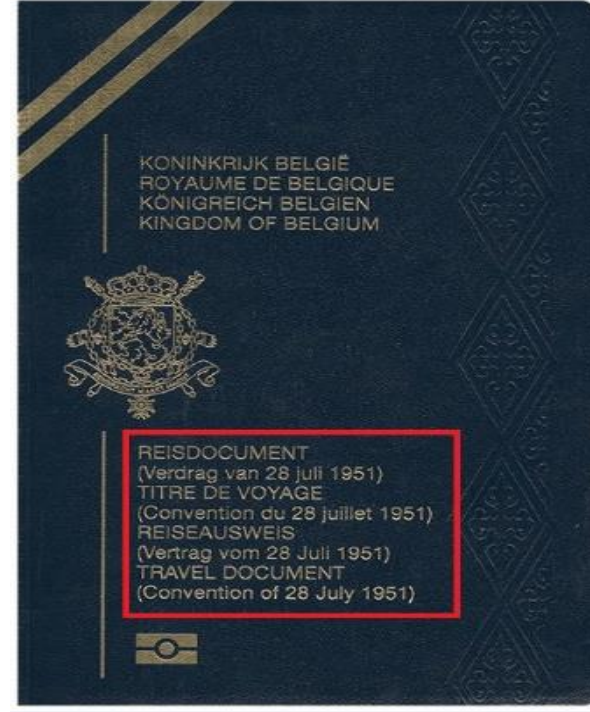

REFUGEE PASSPORTS!

- All refugee passports can enter Türkiye with only valid consular sticker visa inside the passports. (Except Latvia, Lithuania and Estonia Travel documents)
- Refugee passports are **not valid** with an **E-visa**.
- Refugee passports have various phrases on them or on the biopages ; *Travel Document, Titre De Voyage, Refugee, Asylum, Alien's exc.* **Passports with these phrases cannot enter Türkiye without a consular visa.**

Red Marked Place; Important to check number of entries, validity and duration of stay. If the visa of entry is single type, you need to check the stamps inside the passport in case of the visa has been used before.

Green Marked Box; The information added as nationality on the e visa has to match with the Passport nationality Passenger is using.

Purple Marked Box; Passport type information entered in the e visa has to match with the Passport Passenger is using. If passenger selected the document type as an ordinary passport, It is obligatory to have an ordinary passport of the country added to the nationality part of the passenger.

If a supporting document is needed then the document type (visa/residence) and number has to match with the document the Passenger holds.



NO REFUGEE PASSPORT IS NOT VALID WITH AN E-VISA!!!

PASSPORT VALIDITY!

- Countries whose citizens are allowed to enter Türkiye with their expired passports only mentioned below.
- **No other country passports** can enter Türkiye if the passport is valid for less than 61 days.
- **If the passports are valid between 61 days and 150 days, they can enter by paying a penalty.**

1. Germany – Passports expired within the last year / ID's expired within the last year
2. Belgium - Passports expired within the last 5 years.
3. France - Passports expired within the last 5 years.
4. Spain - Passports expired within the last 5 years.
5. Switzerland - Passports expired within the last 5 years.
6. Luxemburg - Passports expired within the last 5 years.
7. Portugal - Passports expired within the last 5 years.
8. Bulgaria – Valid ordinary passport



****ID CARDS TRAVELLING TO TURKIYE****

- **No other country** can enter Turkiye with their national identity cards.

DOMESTIC CONNECTION FLIGHTS!

- If passengers have connection flight in Türkiye, they have to enter first destination border.
- Passengers who have a reservation to the last destination with same flight number after SAW, no need to require to enter Türkiye.
- Reservation with different flight numbers to the last destination after SAW, passengers need to enter first to Türkiye.
