1. Closing all exterior hatches of the aircraft;
2. Closing all exterior doors of the aircraft not served by a bridge;
3. Locking the door between the terminal and the bridge;
4. Ensuring no portable stairs, lift devices or passenger transfer vehicles are in the immediate vicinity of the aircraft;
5. Locking or keeping under constant surveillance doors that provide access to the bridge from the apron or retracting the bridgehead from the aircraft and deactivating the bridgehead positioning controls.
