


Saudi Arabia travel restrictions during the «Hajj season»





The Hajj Season will take place
between

«May 30th 2023 and June 28th 2023»

some travel restrictions will be applied to
the relevant country.



The restrictions to be applied for our **Saudi Arabia** flights between the dates mentioned above are as follows;

Passengers with **Hajj Visa** can only be accepted on **JED (Jeddah)** and **MED (Medina)** flights.

(For passengers who will travel there with a transfer flight, no action should be taken without confirmation from us.)





Passengers with a **Hajj visa** should definitely not
be accepted on
RUH (Riyadh) and **DMM (Dammam)** flights.





Business and Commercial visa holders should never be
accepted on
JED (Jeddah) and MED (Medina) flights.



For passengers with
**Government, Diplomatic, Official, Diplomatic Mission
and Organization Visas,**
no action should be taken without confirmation from
us before accepting them
on **JED (Jeddah)** and **MED (Medina)** flights.





Tourism travel conditions of Saudi Arabia during Hajj season



Countries which are eligible to visa on arrival / tourist visa:

Andorra, Australia, Austria, Belgium, Brunei, Bulgaria, Canada, China (including Honk Kong and Macau), Croatia, Cyprus, Czech Republic, Denmark, Estonia, Liechtenstein, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Kazakhstan, Japan, Latvia, Romania, Lithuania, Luxembourg, Malaysia, Malta, Monaco, Montenegro, Netherlands, New Zealand, Norway, Poland, Portugal, Russia, San Marino, Singapore, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, Ukraine, United Kingdom, United States citizens.



Countries which are **NOT** eligible to visa on arrival / tourist visa

must either have a consular visa or have documents that meet the following conditions

in addition to their passports in order to benefit from the touristic travel condition.



- 1) In addition to the **Normal passports** of their countries,
the residence card must
be **indefinite** and **physically declared** for the
passengers with
the **United States, United Kingdom, Schengen**
residence card.



2) In addition to the **Normal passports** of their countries,
the passengers who will travel with the
United States, United Kingdom, Schengen
visas
must have **a valid visa** and have **been used at least once for the issued country**.



3) In addition to the **Normal passports** of their countries,

*the residence card must **be valid** and **physically declared** for the passengers who have a residence permit in the*

Gulf Cooperation Council states (GCC).



4) *Passengers **younger than 18 years** who travelling to Saudi Arabia must be accompanied by a **parent/guardian** to obtain a visa on arrival.*

Passengers younger than 18 years who traveling alone **are not accepted** by Saudi Arabia as they **cannot obtain a visa on arrival.**

Gulf Cooperation Council: Bahrain, Kuwait, Oman, Qatar, Saudi Arabia, United Arab Emirates.

Schengen States: Austria, Belgium, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Slovakia, Slovenia, Spain, Sweden, Switzerland.

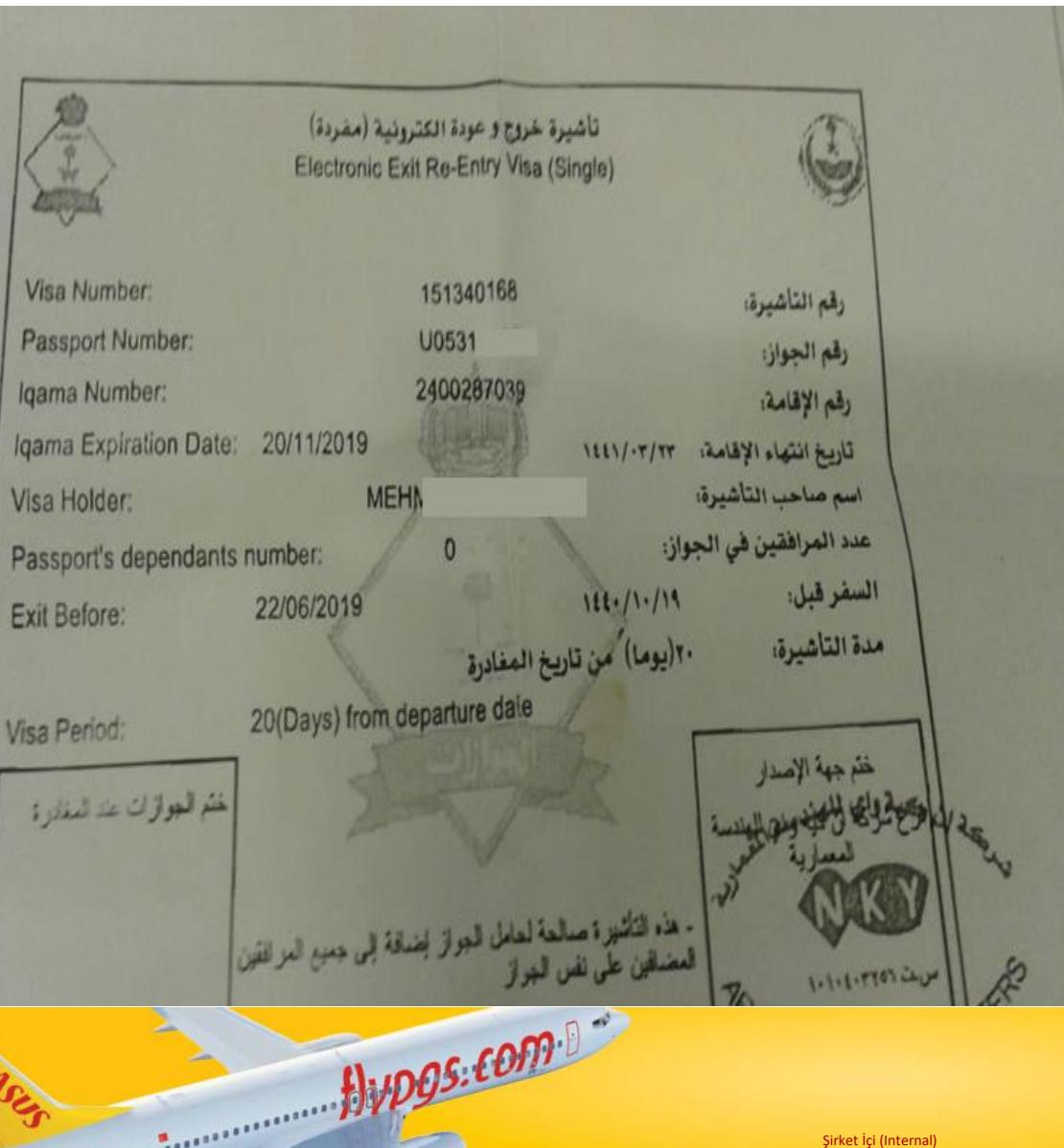

- This Visa is valid for passport holder and all dependents added on the same passport
- You are allowed to stay in KSA up-to 90 days from the issuance date or until the Exit Before date
- You are not to allowed to enter KSA if your Iqama has expired or after Exit –Entry Visa expiry date (whichever comes first)


