Reason for Issue

Travel to the UK

The UK Home Office has confirmed that from 2nd June 2025 GBR issued Biometric Residency Permits (BRP's) and GBR issued Biometric Residency Cards (BRC's) which expired on or after 31st December 2024 will no longer be permitted for travel to the UK, the last date these documents will be acceptable is upto and including 1st June 2025. This SI updates information previously issued on SI303/2024.

Details

An increasing number of customers will be travelling to the UK with an immigration status that is held digitally. Customers who previously held BRP or BRC's will now be travelling using an eVisa and may no longer have a physical visa or other permission document to inspect. To ensure a smooth transition to eVisa's the Home Office is extending the measures to allow BRP's and BRC's that expired on or after 31st December 2024 to accepted as evidence of permission to travel to the UK up to and including 1st June 2025.

Examples of the acceptable documents are below:

1. Biometric residence permit



2. EU Settlement Scheme biometric residence card
