## Reason for Issue:

Due to the Africa Cup of Nations football tournament taking place in Morocco, there is a temporary change of document requirements for some nationals travelling to Morocco, with some exemptions.

Applicable Routes:

- All airports with routes to Morocco

### Details:

A travel restriction applies for all customers flying to Morocco and holding passports issued by:

- Algeria
- Burkina
- Cape Verde
- Gabon
- Niger
- Senegal
- Togo
- Tunisia.

From 25<sup>th</sup> of September 2025 to 25<sup>th</sup> of January 2026, customers holding a passport from those countries must complete an Electronic Travel Authorisation (ETAM), and be able to present proof to Ground Crew on request. Example below (family name redacted for privacy reasons):-

There are also listed exemptions, Holders of Diplomatic Passports, Service, Special or Official passports. Residents of Morocco holding a valid Residence Permit, spouses of Morocco nationals (with proof), persons aged over 55 years.

E) ALL AIRLINES OPERATING TO THE KINGDOM OF MOROCCO ARE HEREBY INFORMED THAT, WITHIN THE FRAMEWORK OF THE ORGANIZATION OF THE 35TH AFRICA CUP OF NATIONS (CAN 2025), TO BE HELD FROM 21 DEC 2025 TO 18 JAN 2026, SPECIFIC MEASURES RELATED TO THE ELECTRONIC TRAVEL AUTHORIZATION TO MOROCCO (ETAM) WILL BE IMPLEMENTED.  
1. CONCERNED COUNTRIES:  
ALGERIA, BURKINA FASO, CAPE VERDE, GABON, NIGER, SENEGAL, TOGO AND TUNISIA.  
2. REQUIREMENTS:  
NATIONALS OF THE ABOVE-MENTIONED COUNTRIES, HOLDERS OF ORDINARY PASSPORTS, ARE REQUIRED TO OBTAIN AN (ETAM) IN ORDER TO ENTER MOROCCAN TERRITORY BETWEEN 25 SEP 2025 AND 25 JAN 2026.  
3. PROCEDURES:  
-CAN SUPPORTERS: REQUEST VIA (YALLA) APPLICATION (DEVELOPED BY FRMF).  
-OTHER PURPOSES (TOURISM, BUSINESS, ETC.): REQUEST VIA WEBSITE [HTTPS://WWW.ACCESS-MAROC.MA](https://www.access-maroc.ma), MINIMUM 96 HR PRIOR TO FLIGHT.  
-(ETAM) PRESENTATION MANDATORY AT BOTH BOARDING AND ARRIVAL.  
4. EXEMPTIONS:  
- HOLDERS OF DIPLOMATIC, SERVICE, SPECIAL, OR OFFICIAL PASSPORTS.  
- RESIDENTS IN MOROCCO HOLDING A VALID RESIDENCE PERMIT.  
- TRANSIT PASSENGERS (WITHOUT LEAVING THE INTERNATIONAL ZONE).  
- SPOUSES OF MOROCCAN NATIONALS (UPON PROOF).  
- PERSONS AGED OVER 55 YEARS.  
5. REQUIRED ACTION:  
AIRLINES ARE REQUIRED TO INFORM THEIR CREWS AND AFFECTED PASSENGERS AND TO ENSURE COMPLIANCE WITH THESE REQUIREMENTS AT BOARDING FOR FLIGHTS TO MOROCCO.)
