## CUSTOMER ENTITLEMENTS

- All customers can bring on board one small cabin bag (max. 45 x 36 x 20 cm), which needs to be kept under the seat in front.
- Customers who have paid for a large cabin bag can also bring on board a large cabin bag (max. 56 x 45 x 25 cm), which needs to fit in the overhead locker.

There is a weight restriction of 15kg per cabin bag. Customers must be able to place and retrieve the bag safely in the overhead lockers without assistance.
