



Topic: About Turkey & Iran E-Visa Checks- Updated Implementation Instructions

Dear Partners,

It has been observed that there has been an increase in repeated questions regarding Turkish and Iranian e-visas in recent times.

Attached are updated documents for e-visa checks. All checks must be done according to these documents to avoid errors and ensure the operational process.

To prevent errors in visa verification and accelerate the operational process, the following points must be carefully applied:

1. E-visa checks for passengers traveling to Turkey

- The e-visa must match the passport information exactly.
- E-visas with mismatched passport information are strictly invalid and will not be accepted.
- Passengers traveling with an e-visa are required to present any supporting or supplementary documents requested in addition to the e-visa (visa/residence permit).
- Passengers with missing supporting documents will not be allowed to board.

2. E-visa checks for passengers traveling to Iran

- The e-visa must be valid and the passport information on the e-visa must match the passport.

If the above conditions are met:

- The e-visa is accepted.
- No further questions regarding the same information will be asked.
- No additional documents or approvals are required.

Visa verification is the responsibility of the staff. Accordingly, repeated questions regarding the points clearly stated in the attached documents will not be answered separately, and the relevant checks must be conducted directly based on these documents.

We kindly request that you review the presentation to ensure the correct implementation of the procedures.

- E-visas issued by Iran include an **"Issue Details or Grant Details"** field.
- If this section contains all the details such as the visa type, issue date, duration of stay, start and end dates, it means that the visa has been approved. The document also includes a **"VISA NO"** field that proves the existence of the visa.
- Before traveling, the start and end dates of the visa must be checked and all information in the e-visa must be matched exactly with the passport.

- **It does not contain a start or end date.**
- Since this is not a visa, **there is no "VISA NO" field on it.**
- If the passenger applies for a flight with this document, the QR code on it must be scanned. If the information that the visa is approved (**Application status: Issued**) can be reached when the QR code is scanned, the passenger can be accepted to the flight. However, **if the visa is not approved, the passenger should not be accepted to the flight.**



DISCLAIMER
In case that the records in your e-visa and passport differ, your e-visa will be deemed invalid. In the event that the information which you provide at your visa application and the information recorded in your passport differentiate, your e-visa will be invalid. If the persons recorded to the accompanying section of your passport are to travel with you, it is essential that they also get e-visa.

E-visa shall not be valid for purposes other than touristic and commercial trips. Visa applications such as work, study, etc. must be made via foreign missions of Turkey.

E-visa system does not monitor the days of your stay/residence in Turkey. Hence, it is your own responsibility to check whether your residence permit has expired or not.

Should your stay upon single entry without residence permit be longer than 30 days, you may well be sentenced to administrative fine and your entry into Turkey might be forbidden for a certain period of time.


In exceptional circumstances, it is possible that Turkish authorities may not permit an e-visa-holder to enter into Turkey. For more information, please visit <http://www.evisa.gov.tr/tr/en>

- When the passenger applies for a flight with an e-visa, it must be checked whether the information on the visa matches the details in the passport.

- My age is below 18 or over 35.
- I have a valid Supporting Document (Valid visa OR valid residence permit from one of the Schengen Countries, USA, UK or Ireland). E-visas are not accepted as supporting documents.
- I hold a passport valid for at least 6 months from the date I intend to enter Turkey.
- I am travelling for the purposes of tourism or business.




Check the start and end dates of the visa. Pay attention to whether the visa is single or multiple entry. Multiple entries cannot be made with a single entry visa. This check should be done by examining the Turkish entry stamps in the passport.

Match the nationality on the e-visa with the passport.
Check if the passport type on the e-visa matches the passenger's passport.

Make sure the document number and validity dates are correct.

If a supporting document is needed, make sure that the information for this document is entered correctly.
