PURPOSE

This Local Operating Procedure (LOP) establishes a standardised process for the handling, supervision, and protection of Unaccompanied Minors (UMNR) at departure and arrival for Pegasus Airlines at Munich Airport (MUC). This procedure aims to ensure the welfare of UMNR passengers, clear accountability of staff, and alignment with airline, regulatory, and safety requirements throughout all stages of their journey.

OBJECTIVE

The objectives of this LOP are to:

- Ensure the **safety, security, and well-being** of all Unaccompanied Minor passengers at all times while under the responsibility of ground handling staff.
- Provide **clear roles and responsibilities** for all personnel involved in the handling of UMNRs, including check-in agents, boarding staff, supervisors, and arrival personnel.
- Standardise procedures for the **correct completion, distribution, and control of UMNR documentation** (UM Form and UM Envelope).

GENERAL INFORMATION

Any child under 12 years of age must be accompanied by an adult who is 18 years or older, unless the child, aged between 6 years 1 day and 11 years 11 months 30 days, is travelling as an Unaccompanied Minor (UMNR) in accordance with the UMNR procedure.

A passenger who has reached their 12th birthday up to, but not including, their 18th birthday is defined as a Young Person (YP). Upon request from relatives or guardians, the YP status may be highlighted to Cabin Crew, who will provide additional attention during the flight. Transport of Young Persons does not require completion of any special forms or



formal procedures. Children aged over 6 years and under 12 years (between 6 years 1 day and 11 years 11 months 30 days) may be accepted to travel alone as an Unaccompanied Minor (UMNR). Booking and ticketing for minors in this age group can only be processed via the Pegasus Airlines Call Centre.

Transfer UMNRs are not accepted on PGT flights.

PROCEDURE STEPS

HANDLING OF OUTBOUND UMNR

Step	Action																																																									
1.	An Unaccompanied Minor (UMNR) must be brought to the airport of departure by a parent or legal guardian . This ensures the child's safety, proper check-in, and handover to airline staff in compliance with company and regulatory procedures.																																																									
2.	Upon arrival at the check-in counter: <ol style="list-style-type: none">Request and verify the UMNR's travel documentation from the accompanying parent or legal guardian.Locate the passenger in the Departure Control System (Crane DCS).Confirm that all required remarks and SSR (Special Service Request) codes related to the UMNR are correctly entered and displayed in Crane. This ensures the child is properly registered in the system and that all necessary safety and handling measures are in place before departure.																																																									
3.	Complete the UMNR Handling Advice/Declaration (Form PG-DO-FR-051) in full, ensuring that: <ul style="list-style-type: none">The responsible adult (parent or legal guardian) has fully completed the form and signed the authorization section.Valid proof of identity has been provided and verified. 4.	<p>Once the UMNR form is fully completed, signed, and verified:</p> <ul style="list-style-type: none"> • Proceed with standard check-in procedures for the unaccompanied minor, including: <ul style="list-style-type: none"> ○ Issuing the boarding pass, ○ Tagging any checked baggage, and ○ Ensuring all SSR codes and special handling requests are confirmed in the system. <p>This step ensures the UMNR is properly processed for travel while maintaining safety, security, and compliance with airline protocols.</p>
5.	<p>After completing check-in for the UMNR:</p> <ul style="list-style-type: none"> • Give the parent or legal guardian the first copy of the UMNR form, and place all remaining copies of the completed UMNR form together with the UMNR's passport and boarding pass into the UMNR envelope.
6.	<p>The UMNR Envelope must be also fully filled out.</p>
7.	<p>Inform the Supervisor on Duty that the unaccompanied minor and the accompanying parent or legal guardian will come to the office to obtain a special gate pass for the accompanying adult.</p>
8.	<p>Advise the responsible adult (parent or legal guardian) that:</p> <ul style="list-style-type: none"> • They must remain at the airport until the aircraft is airborne. • They must proceed to the DHS office to collect a special gate pass. <p>The Supervisor or Lead Agent will:</p> <ul style="list-style-type: none"> • Issue the gate pass, and • Direct the accompanying adult to proceed to the boarding gate together with the UMNR and wait until boarding begins.
9.	<p>When boarding an Unaccompanied Minor (UMNR):</p> <ul style="list-style-type: none"> • Pre-board the UMNR whenever operationally possible to ensure a smooth and safe boarding process. • The boarding agent escorting the UMNR must wear a high-visibility vest at all times for identification and safety. • The UMNR must be personally handed over to a designated cabin crew member. • The receiving cabin crew member must sign the UMNR form to confirm receipt of the passenger.
10.	<p>After the cabin crew member signs the UMNR form upon receiving the passenger:</p> <ul style="list-style-type: none"> • The 2nd copy of the UMNR form remains at the departure station for record-keeping. • The responsible boarding agent must retrieve this copy from the cabin crew after boarding and submit it to the Supervisor or Lead Agent.
11.	<p>Prior to boarding, the Unaccompanied Minor (UMNR) must:</p> <ul style="list-style-type: none"> • Remain under staff supervision at all times. • Be kept in safe custody to ensure their safety and security. <p>Important:</p> <ul style="list-style-type: none"> • Under no circumstances shall the UMNR be allowed to wander unaccompanied in the terminal or airside areas.
12.	<p>OPS: Arrival station involved have to be notified by the passenger service message (PSM) of the UMNRs name, age, flight number, date and routing.</p>
13.	<p>Once confirmation is received that the aircraft is airborne:</p> <ul style="list-style-type: none"> • The Supervisor or designated staff member shall inform the responsible adult (parent or legal guardian) that they may leave the airport.



HANDLING OF INBOUND UMNR

Step	Action
1.	OPS notifies Passenger Handling supervisor on duty of the inbound UMNR.
2.	Supervisor on duty organises the agent who will meet inbound UMNR on arrival.
3.	When assigned to meet an arriving Unaccompanied Minor (UMNR) : <ul style="list-style-type: none"> • Coordinate in advance with OPS/TRC to arrange: <ul style="list-style-type: none"> ○ Airside access, and/or ○ Aircraft transfer, if required.
4.	When meeting an arriving Unaccompanied Minor (UMNR) : <ul style="list-style-type: none"> • Arrive at the gate or designated position well in advance of the aircraft's arrival. • While airside, ensure you are wearing a high-visibility vest at all times for identification and safety.
5.	Upon the aircraft's arrival: <ul style="list-style-type: none"> • Meet the UMNR at the aircraft door. • Collect all relevant travel documents from the cabin crew, including the UMNR form and any accompanying paperwork.
6.	When meeting an arriving Unaccompanied Minor (UMNR) : <ol style="list-style-type: none"> 1. Verify the UMNR form provided by cabin crew: <ul style="list-style-type: none"> ○ Ensure the form is fully completed. ○ Confirm that the details of the person meeting the UMNR on arrival are clearly stated. 2. Sign the UMNR form to formally accept responsibility for the minor. 3. Once signed, the cabin crew will release the 5th and 6th copies of the UMNR form to you for proper record-keeping and onward handling.
7.	After accepting responsibility for the arriving Unaccompanied Minor (UMNR) : <ol style="list-style-type: none"> 1. Escort the UMNR from the aircraft to the terminal. 2. Accompany the UMNR through passport control or any other arrival formalities. 3. If the UMNR has checked baggage, proceed to baggage claim and collect it on their behalf. 4. At all times, the UMNR must remain under your supervision and must never be left unattended.
8.	After exiting baggage claim : <ol style="list-style-type: none"> 1. Locate the person designated to meet the UMNR on arrival. 2. Request official identification (ID card or passport). 3. Verify that the individual matches the details recorded on the UMNR form.
9.	If the identity of the person meeting the UMNR is confirmed : <ol style="list-style-type: none"> 1. Ask the receiving adult to sign the UMNR form. 2. Hand the 5th copy of the UMNR form to the Supervisor for record-keeping. 3. Place the 6th (final) copy back inside the UMNR envelope. 4. Once all signatures are collected and documentation is properly distributed, formally release the UMNR by handing the child over to the authorized adult.
10.	If the person present to collect the Unaccompanied Minor (UMNR) does not match the individual named on the UMNR form: <ul style="list-style-type: none"> • Do not release the UMNR under any circumstances. • Maintain supervision of the child and notify the Supervisor immediately for further instructions.



11.	If the individual attempting to collect the UMNR does not match the details on the UMNR form: <ol style="list-style-type: none">1. Immediately inform the Supervisor on Duty.2. Escort the UMNR along with the person presenting themselves to the office while the situation is clarified.3. Maintain close supervision of the UMNR at all times until proper authorization is verified.
12.	When a handover discrepancy is identified: <ul style="list-style-type: none">• The Supervisor will contact the Guest Control Centre (GCC) to:<ul style="list-style-type: none">○ Report the discrepancy, and○ Request further instructions on how to proceed safely.
13.	<ul style="list-style-type: none">• The Guest Control Centre (GCC) will review the situation and provide guidance on the next steps.• The UMNR must not be released to any individual without explicit confirmation and authorization from the airline.

SAFETY / SECURITY NOTES

- Unaccompanied Minor (UMNR) passengers are not permitted to travel with PETC (Pet in Cabin).
- A child aged between **6 years 1 day and 11 years 11 months 30 days** may travel accompanied by a Young Person (YP); however, in such cases, the **full Unaccompanied Minor (UMNR) procedure must still be applied**.
- The seating allocation for an Unaccompanied Minor must ensure that cabin crew can maintain **visual or audible contact** with the child at all times during all phases of the flight.
- Unaccompanied Minors **must not be seated in emergency exit rows**.
- Unaccompanied Minors **must not be seated next to INAD, DEPA, or DEPU passengers**.
- UMNR passengers shall be seated **next to a responsible adult passenger** who is capable of providing assistance in the event of an emergency. This passenger must:
 1. Not be classified as a Special Category Passenger (SCP), and
 2. Have no other responsibilities that could prevent them from assisting the UMNR (e.g., an adult travelling alone is acceptable, whereas an adult travelling with young children is not).
- The **maximum number of Unaccompanied Minors permitted on any flight is eight (8)**.
