Topic: Entry Rules for Egyptian Citizens with Turkish E-Visas

Dear Partners,

Recently, there has been an increase in the number of Egyptian citizens admitted to Turkey with invalid e-visas. Therefore, we would like to remind you of the relevant rules and provide you with updated information.

Egyptian citizens can travel with a Turkish e-visa under the following conditions:

- **Egyptian citizens under the age of 20 and over the age of 45** can obtain a Turkish e-visa without any supporting visa or residence permit.

- **Egyptian citizens between the ages of 20 and 45** must have a valid visa or residence permit from Schengen countries, the United States, the United Kingdom, or Ireland in order to obtain a Turkish e-visa.
