I would like to point out to everyone again how important it is that Timatic is read and understood correctly. If there is still any uncertainty after that, please contact the visa team as always with all the data and details needed to avoid misunderstandings.

. Passengers must have an electronic or a printed e-visa confirmation. Airlines must check all the additional requirements specified on the e-visa confirmation. A supporting document such as a third country visa or residence permit may be required. Used single entry visas are accepted as supporting documents if they are not expired on the day of entry to Turkiye.
