## Café Rundblick

Dear Customers,

We would like to inform you about the procedure for the announcement "Café Rundblick" in the terminals. We ask that you inform your employees about the procedure, but to treat it confidentially.

The Federal Police can activate the procedure in the event of a threat against Frankfurt Airport. This is done by means of an announcement in the terminal buildings.

For every employee who hears the following announcement,

**„Achtung, eine Durchsage an das Schalter- und Verkaufspersonal:  
Das Café Rundblick ist ab sofort geöffnet.“**

the following rules of conduct apply:

- Check your place of work for any suspicious objects.
- Watch out for persons behaving strangely.
- Immediately report anything suspicious to Fraport AG's security center (Tel. Intern: 114, Tel. From outside: 069 690-114).
- Questions from third parties about the meaning of Café Rundblick should be answered with the statement "Canteen for employees".

The above announcement is **not** a request to evacuate the terminals.
