Subject:	Corendon Airlines – Cabin Baggage Procedure

Dear partners,

Cabin baggage comprises all articles not listed as personal effects but wanted in the cabin by the passenger during the flight. Cabin baggage must be restricted to 1 piece carry on bag (laptop, woman hand bag, briefcases or baby bag) and 1 piece cabin baggage per passenger occupying one seat and he/she is responsible for such baggage.

The conditions under which these are accepted in the cabin are:

- *Maximum Weight: 8 kg*
- *Maximum dimension: 55 * 40 * 25 cm (cabin baggage)
40 * 30 * 15 cm (carry-on baggage)*

Procedure at check in desk:

- Assess the size, weight and intended number of pieces of cabin baggage to meet the Corendon Airlines's standards.
- Weigh all cabin baggages,
- Refer the passenger to the baggage sizer, if available.
- Attached an "cabin bag tag".

Sample is below:



- If the passenger is willing the cabin baggage to be checked-in, the cabin baggage is accepted as free of charge and inserted into DCS as follows:

ii. If you are using another DCS than I-port, please add the appropriate SSR code into DCS.

Procedure at Boarding

- Check for items which are unacceptable, oversized, overweight or exceed the number of pieces as free cabin baggage, using the cabin baggage sizer if applicable
- If the cabin baggage exceeds the free allowance size and/or weight, it must be hold-checked.
- And Passenger should pay 75€ penalty fee if he/she hides his/her additional cabin baggage and/or oversize cabin baggage.
