Comment PAP with Visa OK

Passport must be valid 150 days beyond arrival time in Turkey

In case of GREEN response from system the PAP is good to go, but ORANGE and RED must be investigated

	Complicated pregnancy: Medical certificate required confirming 'fit to fly' In case PAP has no medical certificate, Indemnity Form must be filled out.
