

## Topic: About Travel Documents Announcement Section

Dear Partners,

As Pegasus Airlines, the rules that make the most mistakes regarding the entry rules of the countries we travel to and that are announced by us have been added as "**Travel Documents Announcement**" in our DCS system.

In the admission of our guests to the flight, the TIMATIC query should be used first and then the **Travel Documents Announcement** section should be checked.

**Travel Documents Announcement**

**INTERNATIONAL FLIGHTS PASSENGERS ENTRY REQUIREMENTS**

**TURKIYE**  
**PASSPORT RULE**  
- Passport validity period must be more than 150 days.  
o Passengers with passport validity between 61-150 days can enter the country by paying a penalty upon arrival, those with less than 60 days cannot enter. For exemptions and detailed information, please check Timatic.  
o This rule does not apply to citizens of countries who can travel to Türkiye with their ID cards.

**VISA RULE**  
- All refugee passports must have consular visas to enter Türkiye (except for Estonia, Latvia and Lithuania). For exemptions and detailed information, please check Timatic.

**AZERBAIJAN**  
**ID CARD RULE**  
- Turkish citizens are only allowed to exit from Türkiye to Azerbaijan with their biometric identity cards with a photo.

**BELGIUM**  
**VISA RULE**  
- The names and surnames on the residence card of the passengers who want to travel to Belgium must exactly match the names and surnames in their passports.  
- Passengers who want to travel to Belgium with a residence permit must have a passport suitable for the reason for their application to Schengen countries. If the residence card is obtained as a result of the asylum application, there are phrases on the card that mean that the person is a refugee. These phrases differ in their own language for each Schengen country. - Passengers with the relevant residence cards must have a refugee passport of that country with them, they cannot travel with a normal passport.  
Bulgaria, Romania and Cyprus residence permits (including family member residence permit) are not accepted to Belgium. Only Bulgarian "Beneficiary under Article 3-2 of Directive 2004-38-EC, Family member under Directive 2004-38-EC and Residence card Family Member of a Bulgarian" type residence cards can travel.

**DENMARK**  
**VISA RULE**  
- Bulgaria, Romania and Cyprus residence permits (including family member residence permit) are not accepted.
