Topic: PETC and AVIH 2024

Dear all,

From 1st January 2024 the completion of a checklist for AVIH and PETC will now be mandatory.

Please ensure that a sufficient checklist is completed at each check-in for **AVIH and PETC**. For PETC, the checklist or a copy must be given to the passenger. For AVIH, the completed checklist or a copy must be attached to the transport crate. PETC and AVIH without a checklist will no longer meet the legal requirements from January 1, 2024, and must be excluded from transport.

The IATA checklist is saved on the desktop under '*IATA PETC and AVIH checklist*'. Please make sure you have a copy at check-in and gate for flights with PETC and AVIH.
