PETC (Pet in cabin)	GHM 6.3.5 and 6.4.1		<p>Must be pre-booked and fee charged, never be seated in front row or exit seats</p> <p>Max. 2 PETC per Aircraft and max 8kgs gross</p> <p>The size of the container may not exceed the dimensions of:</p> <ul style="list-style-type: none"> <li>↳ on B 787, B 737: 55 x 40 x 20 cm on E70, E75, E95, DH4: 45 x 30 x 20 cm</li> <li>↳ Dogs, cats and ferrets requires PET passport</li> <li>↳ Polish law does not allow to bring into Poland young dogs, cats or ferrets under 12 weeks of age without valid vaccination against rabies</li> </ul>
SVAN (Service Animal in cabin)	GHM 5.11.2.1		<p>Assistance dog which may be accepted in the cabin.</p> <p>Trained service dogs (SSR: SVAN):</p> <ul style="list-style-type: none"> <li>∅ Seeing eye dogs trained to lead passengers with impaired vision;</li> <li>∅ Hearing aid dogs trained to lead passengers with impaired hearing;</li> <li>∅ Other service dogs trained to support physically disabled person by i.e. retrieving objects that are out of their reach, by pulling wheelchairs, opening and closing doors, assisting ambulatory tasks;</li> <li>∅ Rescue dogs.</li> </ul> <p>SVAN has to be equipped with harness and the passenger has to possess a muzzle to put on the dog if necessary.</p>

AVIH (Animal in Hold)	GHM 6.4.3	<p>Information of animal (total weight together with the container, dimension of the container) shall be entered into the booking system</p> <p>All the rules that apply to baggage check-in are also relevant for the check-in of a passenger travelling with a live animal carried as baggage.</p> <p>A live animal carried as baggage can be accepted for carriage only during check-in at the airport on the day of departure.</p> <p>Single-leg or multi-leg tag.</p> <ul style="list-style-type: none"> <li>· LIVE ANIMALS label</li> <li>· THIS WAY UP</li> </ul> <p>Every live animal container must bear at least one (1) live animals sticker, with package orientation "This Way Up" on all four (4) sides whenever possible. The labels shall be affixed to the container in such way as not to obscure ventilation openings.* It is prohibited to load AVIH on the following A/C:ERJ190-200AR(SP-LNG, SP-LNH, SP-LNI, SP-LNK, SP-LNL, SP-LNM, SP-LNN)ERJ190-100AR(SP-LME, SPLMF)* Immediately notify ONN for change of A/C registration, if not possible ask ONN to contact the PAX with AVIH.</p>
PRM (Passenger with Reduced Mobility)	GHM 5.11.1	<p>Categories of PRM:</p> <ul style="list-style-type: none"> <li>▷ medical cases,</li> <li>▷ non-medical cases.</li> </ul> <p>Considering the level of mobility impairment, PRM may be also classified as:</p> <ul style="list-style-type: none"> <li>▷ walking passengers,</li> <li>▷ not walking passengers</li> </ul>
STCR (Stretchers)	GHM 5.11.4	This service is suspended, see more GHM 5.11.4
WCH* (Wheelchair)	IATA SSR Code table	<p>WCHR: Requires wheelchair for distance to and from A/C only</p> <p>WCHS: Cannot ascend/descend stairs/steps but no assistance in A/C cabin necessary</p> <p>WCHC: Passenger totally immobile and need full assistance up to A/C seat</p>
WCMP (Wheelchair - Manual Power)	GHM 5.11.7	A manually powered wheelchair, passenger-owned
BLND, DEAF	GHM 5.11.2	Passenger who is blind or/and deaf and needs assistance.
MEDA (Medical Assistant)	GHM 5.11.1	<p>Passengers who suffer from an illness (marked in the booking system by the MEDA code) for whose carriage doctor's approval is required (required documents: MEDIF forms).</p> <p>Passengers who require medical assistance, additional oxygen for breathing or other specialized medical equipment during the flight,</p> <p>Passengers whose behaviour or mental or physical condition, make it impossible for them to travel without additional assistance,</p> <p>Passengers whose health might deteriorate as a result of air travel,</p> <p>Infants up to 7 days of age.</p> <p>Women over 32 week of pregnancy</p>
EMA (Electric Mobility Aid) Subject to Dangerous Goods Regulations, accounted for Load Control and reported to the Flight Captain!	GHM 6.5.2-4.	<p>WCBD: Dry cell battery</p> <p>WCLB: Lithium ion battery</p> <p>WCBW: Wet cell battery</p> <p>May be accepted after further checks of requirements for safe air transportation.</p> <p>Dangerous Goods Regulations and Loading requirements to be checked before acceptance of any EMA!</p> <p>The pilot in command MUST be informed about the location of the mobility aid</p>

DAA (Delivery at Aircraft)	GHM 6.11	<p>Delivery at aircraft baggage is cabin baggage:</p> <ul style="list-style-type: none"> <li>· loaded in hold at the time of boarding and,</li> <li>· return to the passenger when disembarking, i.e. at the aircraft stairs or at the loading bridge.</li> </ul> <p>NOTE:</p> <ul style="list-style-type: none"> <li>▷ It is not considered as checked baggage, although carried in hold.</li> <li>▷ If used for carry-on baggage, the weight is part of the carry-on baggage allowance.</li> </ul> <p>Tag "Delivery at aircraft" shall be used</p>
DEPA (Accompanied Deportee) - Captain and Cabin crew to be informed	GHM 5.13	<p>To be seated in the last rows (window seats).</p> <p>Potentially Disruptive Passengers, who need to be escorted by police or security agents.</p> <p>DEPA:</p> <ul style="list-style-type: none"> <li>▷ Documents remain with the escort (Notification form)</li> </ul>
DEPU (Unescorted Deportee) Captain and Cabin crew to be informed	GHM 5.13	<p>To be seated in last rows (window seat).</p> <p>DEPU:</p> <ul style="list-style-type: none"> <li>▷ Documents shall be given to the senior cabin crew member (Notification form)</li> <li>▷ Upon arrival, the documents must be handed over to the ground staff</li> </ul>
INAD (Inadmissible Passenger) Captain and Cabin crew to be informed	GHM 5.13	<p>Inadmissible passenger means a passenger who:</p> <ul style="list-style-type: none"> <li>▷ is refused admission to a country by authorities of such country or,</li> <li>▷ is refused onward carriage by a Member or government authority at a point of transfer, e.g. due to lack of a visa, expired passport, etc.</li> </ul> <ul style="list-style-type: none"> <li>· There are two categories of INAD:</li> <li>▷ Unaccompanied INAD passengers (in most cases),</li> <li>▷ Accompanied INAD passengers.</li> </ul>
WEAP (Weapon)	GHM 6.6.1-2	<p>Firearms (FRMS) and ammunition (AMMO) (subject to one additional fee)</p> <p>Firearms unloaded, dismantled and packed into special closed containers - max 15 kg</p> <p>Ammunition packed separately in appropriate metal, wood or fibre container provided with safety locks - not exceeding 5 kg, can also be carried as part of the checked baggage.</p> <p>Passenger to fill up and sign "Firearm Deposit Declaration"</p> <p>Firearm to be labelled with corresponding tag</p> <p>BUPOL to be called for assistance at check-in, checking relevant documents and Firearm Pass</p>
Sport Equipment	Website	<p>Subject to additional fee ( depending if domestic, intercontinental or international flight)</p> <p>Maximum weight allowance: 45kg</p> <p>Items allowed for carriage: Bicycle, Archery, Fishing, Golf, Hockey Equipment, Skateboard, Snowboard, Tennis equipment etc...</p>
Instruments	Website	<p>Can be carried in cabin instead of standard cabin baggage or as CBBG</p> <p>For instruments exceeding cabin bag size, an extra seat (EXST) to be purchased</p>
EXST (Extra seat)	GHM 5.3.3	Extra seat is available for purchase for PAP comfort (mostly purchased for oversized passenger, instruments, wedding dresses etc)
CBBG (Cabin baggage)	GHM 5.3.3	<p>Max 75 kgs, combined with a purchased EXST</p> <p>Passenger can not be seated on Emergency exit seat, two boarding passes to be issued to passenger</p>
INFT (Infant)	GHM 5.10.1	<p>&lt; 2 yrs old</p> <p>Limit: The maximum number of infants allowed per aircraft is decided by the number of oxygen masks available on board the aircraft.</p> <p>Maximum 2 infants per accompanying adult over 16 years of age.</p>
CHLD (Child)	Website	2-12 yrs old

UMNR (Unaccompanied Minor)	GHM 5.9.1	<p>1-7 days: an infant less than 7 days old is subject to the procedure concerning carriage of disabled persons,</p> <p>8 days-5 years: an infant or child between 8 days and 5 years old must be taken care of during the journey by a guardian (additional air hostess), specially appointed by LOT Polish Airlines.</p> <p>over 5-12 years: an unaccompanied minor aged over 5-12 years, shall be taken care of during the journey, the care is exercised by a member of the cabin crew, the parents or legal guardians of the child may demand that special care be provided for the child. In such a situation the carriage is subject to the procedure described in item 2 (8 days-5 years).</p> <p>over 12-17 years: young persons aged over 12-17 years can travel completely independently (without the "UM" annotation on the ticket) and are treated as adults (are not subject to the procedure concerning carriage of unaccompanied minors -"UM")</p> <p><b>Documentation:</b></p> <ul style="list-style-type: none"> <li>Request for carriage" form (Handling advice) – mandatory.</li> <li>↳ Contains the waiver of liability, to be signed by parents/guardian.</li> <li>↳ Gives information concerning the UM, routing, adult escort on departure and adult escort upon arrival.</li> <li>↳ Contains several coloured coupons/copies : 4 copies for direct flight, additional white coupon in case of transfer carriage <ul style="list-style-type: none"> <li>· UM document holder bag – mandatory.</li> <li>↳ a slip-on wallet for safe carriage of UM's documents (free of charge),</li> <li>↳ given during the check-in,</li> <li>↳ space provided to fill out name, routing and other details.</li> <li>· UM baggage tags – mandatory.</li> <li>· UM name label/button – if available.</li> </ul> </li> </ul> <p>Limits: depends on the number of the cabin crew: B787(24) / 738/7M8(12) /ERJ 190-100/200(9) // FR1170-100/200(6)</p>
Voluntary UMNR (young traveller with paid UMNR service)	GHM 5.9.1	<p>12-17 years old</p> <p>UMNR service fee booked and paid (handled like an UMNR, see above)</p>
Pregnancy	GHM 5.10.3	<p>Up to the end of the 32th week of pregnancy respective up to four weeks prior to the expected confinement, an expectant mother can freely travel on LOT flights without any doctor's certificate.</p> <ul style="list-style-type: none"> <li>· MEDIF is required in case of expectant mothers after the 32th week of pregnancy or women with complicated pregnancies or expecting twins, triples, etc.</li> </ul> <p>Expectant mothers must not be seated in emergency exit rows.</p>
